**Purpose of position:** The Community Educator is responsible for providing community trainings and presentations for campus communities, helping professionals, Partners for Peace volunteers and staff and more. This position also provides prevention education related to domestic violence, dating abuse, and healthy and unhealthy relationship behavior in collaboration with schools and youth-based programs. This position engages in social media campaigns and awareness event planning related to Domestic Violence Awareness Month, Teen Dating Violence Awareness and Prevention Month, and other initiatives.

1. Provide community education including the Core Comprehensive Advocacy, Intervention, Response, and Ethics (CAIRET) training, community-based trainings including the Maine Coalition to End Domestic Violence 12-Hour Domestic Violence Training for Mental Health Professionals, campus education and outreach; and regular program assessment and evaluation of effectiveness

- 2. Collaborate with schools and youth-based programs to provide age-appropriate prevention education to children and youth on topics such as equality, kindness, healthy relationship behavior, dating abuse and violence, and more; including curriculum development, regular program assessment and evaluation of effectiveness
- 3. Provide high quality trainings, presentations, and awareness events and activities related to domestic abuse intervention and prevention year-round, and especially during October (Domestic Violence Awareness Month) and February (Teen Dating Violence Awareness & Prevention Month)
- 4. Develop educational content for social media, electronic communications, and print materials, in collaboration with the Development Department, especially as it relates to youth
- 5. Cultivate, nurture, and sustain relationships with community partners (schools, universities, businesses, healthcare providers, etc.) to expand the reach of the Partners for Peace Community Education Program
- 6. Engage in direct support and advocacy with individuals and families affected by domestic abuse and violence, especially children and youth; including the staffing of PFP's 24-hour helpline during daytime shifts, some overnights and weekends
- 7. Provide for quality assurance in accordance with state and federal regulations and funding requirements, including data collection and reporting, especially as it relates to training and presentation evaluations
- 8. Perform other duties as assigned

- h) Willingness and ability to employ a survivor-centered, self-help model of service delivery and social justice advocacy
- i) Willingness and ability to work flexible hours, including some nights and weekends
- j) Willingness and ability to provide 24-hour confidential helpline coverage as scheduled
- k) Dedication to the Partners for Peace Mission and Vision and Inclusivity Pledge

### Physical Requirements and Working Conditions:

- a) Must be able to work in a fast-paced, non-smoking, trauma-informed, survivorcentered environment with the potential for stress
- b) Must be able to sit for long periods of time
- c) Must be able to do occasional lifting and transporting of materials
- d) Must be able and willing to provide crisis response services and advocacy to survivors of domestic violence sometimes during evenings and weekends
